3 Terms and definitions

tool intended for cutting various material with a blade or blades acting in a reciprocating or oscillating motion

jig saw

reciprocating saw equipped with a base plate that may allow bevel adjustments

3.103

sabre saw

reciprocating saw with a guide plate that may allow tilting movements

Test procedure

IEC 63241-1:2023, Clause 4 is applicable except as follows:

4.3 Operating conditions

Addition:

Jig saws and sabre saws intended to cut wood are tested under load observing the conditions shown in Table 101.

Table 101 - Operating conditions for jig saws and sabre saws intended to cut wood

Material and set-up	Particleboard (chipboard), class P-LB-Reg in accordance with ISO 16893:2016, density (610 \pm 60) kg/m3, thickness (19 \pm 1) mm, width (400 \pm 2) mm, any length	
	For jig saws:	
	The particleboard (chipboard) is mounted horizontally on a bench with a suitable working height (approximately 900 mm).	
	For sabre saws:	
	The particleboard (chipboard) is mounted vertically by screws, clamps or the like.	
Orientation and operation	Sawing of approximately 10 mm wide strips over the width of 400 mm.	
Tool bit/settings	New saw blade as specified by the manufacturer for sawing particleboard (chipboard) at the beginning of each of the three tests.	
	Speed setting devices, if any, shall be adjusted to the setting specified for sawing particleboard (chipboard).	
	Pendulum setting, if any, is set to maximum.	
Feed force	The feed force applied to the tool shall be sufficient to ensure stable operation with good performance.	
Test	During the working time of one test cycle, 20 cuts as specified above are performed equally distributed over the working time.	
	If the above cannot be achieved within 10 min, the time is extended to allow the required number of strips to be cut.
